Motion by Quin Brunette and second by Steven Butz, Be it resolved by the electors of the Whitnall School District, pursuant to section 120.10(8) of the Wisconsin Statutes, that the tax levy for the 2020-2021 school year shall be set at \$14,392,526 for Fund 10: General Fund, \$118,293 for Fund 38: Non-Referendum Debt Service and \$1,389,181 in Fund 39: Referendum Debt Service.

Capital Expansion Tax Levy:

Treasurer's Report 2020-2021

In the summer of 2021, the accounting firm of Reilly, Penner & Benton LLP, audited the district's financial activities for 2020-2021. The completion of the final audit report is projected at the end of November. Upon completion, the 2020-2021 audit report will be available in the District Office for review.

The 2020-2021 ending Fund Balance demonstrates an increase of \$212,076.51 in the District's designated working cash balance. Causes of the fund balance increase were

- Use of ESSER funding to cover a one-time Special Ed Exception, reducing the Fund 27 transfer
- Better than expected health insurance claims
- Federally funded lunch program resulting in no Fund 50 transfer

Informational: School District Fund Balance

Accounts are summarized on a balance sheet as Assets, Liabilities, and Fund Balance.

The District's fund balance represents:

Beginning Fund Balance

- + Total Assets of a Given Fund (including funds owed to the district as of June 30)
- Total Liabilities of a Fund (including funds owed to others as of June 30)
- = Ending Fund Balance.

The current Fund 10 Balance is 35.5% of the 2020-21 expenditures. It is important to ensure an adequate reserve of assets, as an adequate fund balance affords the Whitnall School District an opportunity to demonstrate financial stability.

An adequate reserve of assets permits our district to:

- Accumulate sufficient assets to make designated/necessary purchases and improvements
- Avoid short-term borrowing to meet expenses, thereby spending operational funds for interest payments
- Preserve a high bond rating
- Ensure available funds for emergency expenditures
